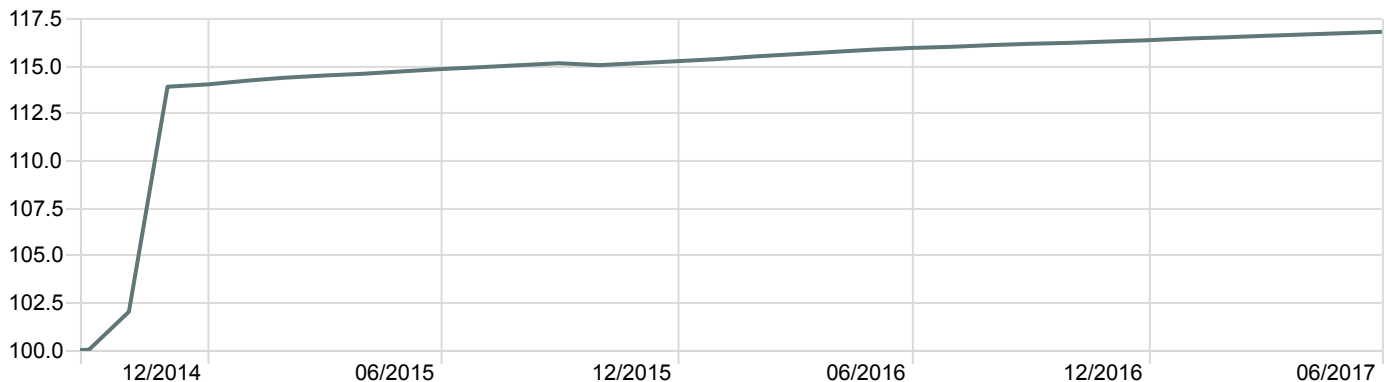

Note: WealthFoundations was launched 23 September 2014. During the initial months after the launch, a significant volume of transactions passed through the Guaranteed Cash fund while its initial net balance was very low. This resulted in some minor timing impacts that boosted the apparent return on the small net balance. This is not anticipated to recur in future now that the fund is established with a larger ongoing net balance. However this will continue to be seen in the longer term return for some time.

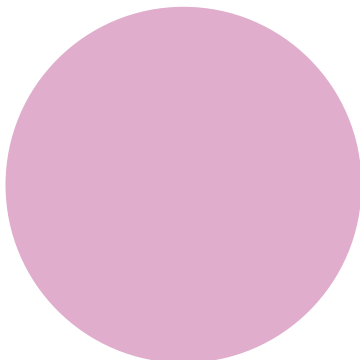
