This includes finding or identifying your superannuation benefits, calculating tax on superannuation payments and providing information to the ATO to enable it, amongst other things, to calculate the surcharge payable, if any. These purposes may change in the future. Your TFN may be provided to another superannuation plan or retirement savings account provider that receives any transferred benefits in the future, unless you notify the Trustee in writing not to forward the TFN. Apart from these uses, your TFN will be kept confidential.
- It is not an offence to not supply your TFN.
- If you choose not to supply your TFN:
 - You may be subject to more tax than you would otherwise pay on your contributions and the payments you receive from ClearView.
 - It may be more difficult to locate your superannuation benefits.
